### 4 DRAWDOWN UPDATE

- Pump operating normally now. As of last Saturday, pond was exactly at its normal height—22 inches below the dam. With spring melt and rainfall, water level should increase another 6 inches

### 5 ACTIVITIES DISCUSSION REVIEW

- Ben and Megan participated as Science Fair judges
- Gathering information on potential Aerial Algal Bloom Survey by a company called Headwall Photonics. If approved, it would take place in early July. There is no cost to this survey.

- Preparing draft of Notice of intent last filed in 2017
- Town meeting on April 29<sup>th</sup>. Encouraging votes to support budget for increased algal bloom monitoring costs
