The proposed location for the sewage disposal system was reviewed by Jim Burns and Liz Allard.

These revisions included extending the length of the level spreader, continuation of the wetland delineation further to the north, and showing the 100' wetland buffer zone on all of the plans. Mr. Brassard also followed up with his colleagues on reducing the effects of salt on wetland resource areas and has determine there are no additional measures above those already put in place by this proposal that would further reduce salt from entering the wetland resource area. Liz Allard requested that the location where snow will be stored be detailed on the plan. Ms. Allard also shared standard conditions for the maintenance of the stormwater facilities with Mr. Brassard who was in agreement with most of the conditions.

With still no file number or comments from the Department of Environmental Protection Mr. Brassard requested the hearing be continued. Jim Burns made a motion to continue the hearing to March 7, 2019 at 7:45pm in the Town Hall Meeting Room, 13 Ayer Road at 7:45pm. Paul Willard seconded the motion. The vote was unanimously in favor of the motion.
