**Eagle Scout Presentation – Jack Babcock**

Depot fields storage and seating, will build two benches 2x2x10, water resistant, able to be moved by one adult, but heavy enough to not be a problem; chains and toy box hinges; timeframe, early to mid July; cost \$500. Keith asked about handles for moving boxes, Jack will take ideas; Bob discussed fund raising. Keith asked about painting or staining, Jack is using decking boards, Keith asked about underneath, Jack will review. Bob mentioned raising the base so as to not create barriers for animals. Feet lifts hole structure off the ground. Michelle mentioned bringing issue to ConCom; Bob to call Liz. Keith motioned to approve the two benches, Doug seconded, vote **5-0**

**Pump Track Presentation (18:00) – Roger Cameron, Todd Currie**

Presentation summarized what we learned last meeting. Special thanks to 17 year old in Acton for borrowed presentation framework; Who we are: outdoor enthusiasts; what is a pump track, small loop trail with berms and rollers – ¼ to ½ acer; Chelmsford pump track (NEMBA – New England Mountain Bike Association) has been huge success, very few problems; proposed land location, center of town, using existing amenities and parking; potential location include lot #8 and #9; design, all dirt bought in, 100+ yards, 1) natural topsoil not disturbed, 2) choose correct dirt, and 3) external dirt easier to establish proper drainage; signage, parking and trash discussed; funded locally and through grants, \$4K-\$5K; closed in winter.
