Meeting convened at 7:32

- 1. Public Comment Period John Osborn, Harvard Press, updated the CPC regarding Finance Committee's reasoning behind not supporting Article 23-3 (Old Library Roof). Capital Planning Investment Committee (CPIC) had voted to change its recommendation regarding the Old Library Roof. They proposed that \$25,000 be spent on a thorough engineering study of the status of the roof to allow a better estimate of the work needed.
- 2. Review Minutes from March 20, 2019 Meeting Minutes, as amended, were accepted by unanimous vote.
- 3. Treasurer's Report According to the April 10, 2019 memo from Community Preservation Coalition, the House Committee on Ways & Means' version of the state budget includes an increase to the recording fees at the Registries of Deeds that would more than double the current CPA Trust Fund revenue. The budget will be finalized in late June, so the Coalition has asked that local CPC's contact their state senators and representatives to gain support for this inclusion in the budget.
- 4. Request to rescind Old Library Roof Renovation Warrant Article and replace with Old Library Roof Engineering Analysis Warrant Article: In light of Finance Committee's decision not to support Article 23-3, discussion was held as to the wording of the CPC Warrant Article for the Old Library and whether to extend the sunset date. Didi spoke with Stuart Saginor at the Coalition and the analysis adjustment would be allowed under the Coalition's regulations. The Coalition language and structural analysis were unanimously approved and the extension of the sunset date was declined. The new wording for the article is as follows:

ARTICLE : SELECT BOARD - OLD LIBRARY ROOF PRESERVATION

To see if the Town will vote to appropriate and transfer from Fiscal 2020 Community Preservation Fund unspecified reserves the sum of \$100,000, to be expended by the Select Board for the purpose of preserving and restoring the roof and gutters on the Old Library building in accordance with the Standards for Preservation defined by the Massachusetts Secretary of the Interior, including any structural analysis associated with conducting this work, with unexpended funds as of June 30, 2021 to be returned to their funding source, or pass any vote or votes in relation thereto.
