# HARVARD CONSERVATION COMMISSION MINUTES OF MEETING APRIL 5, 2018

Chairman Paul Willard called the meeting to order at 7:02pm in the Town Hall, 13 Ayer Road, under MGL Chapter 131 §40 Wetland Protection Act and Code of the Town of Harvard Chapter 119 Wetland Protection Bylaw

Request to Amend Determination of Applicability – Johnston, 82 Warren Avenue, Harvard#0617-02 Mark Saydah, of Whole Earth Landscape and Design, was present to discuss amendments to the site plan approved under a Determination of Applicability last year. Mr. Saydah stated the lower patio area near the house that had been previously shown on the approved site plan is no longer to be constructed. The property owners are seeking to remove some additional white pines and hemlocks along the northern property boundary. The removal of the pines will assist in keeping the oaks healthy.

Jim Burns made a motion accept the revised plan entitled "Johnston Residence", dated 3-26-18 and the narrative in an email from Mark Saydah to Liz Allard, dated March 30, 2018, for 82 Warren Avenue, Harvard#0617-02. Joanne Ward seconded the motion. The vote was unanimously in favor of the motion.

Approve use of conservation land - Harvard Conservation Trust Run for the Hills Event Wendy Sisson made a motion to allow Harvard Conservation Trust to use the area known as Prospect Hill Management Area, specifically Dean's Hill and Newman land, for the 2018 Run for the Hills Event on or about October 21, 2018. Jim Burns seconded the motion. The vote was unanimously in favor of the motion.

The Commission requested the proposal include more detail as to the activities to be performed. The Order of Conditions needs to be reviewed to determine if the Commission required phasing of the tree clearing and whether or not the infrastructure was to be constructed prior to any other activity on the site.
