CPC is looking to understand the funding needs of both the Conservation Commission (ConCom) and Harvard Conservation Trust in context to their overall plans. A case for the funding of land acquisitions can easily be made through the 2016 open space survey and the 5-year open space protection plan, which has been sent to the chair of CPC. This Request for Determination of Applicability was filed on behalf Harvard Conservation Trust for the control of the invasive plant tree of heaven within the wetland resource areas and the associated buffer zone on the Muller Land, on Littleton County Road (Map 18 Parcel 42), Harvard.

Dave Outman, Director of Harvard Conservation Trust, was present to present the application for the control of the invasive plant tree of heaven on the Muller land. The tree of heaven is clustered along the field edge with an abutting property. The proposal is to treat approximately 40 mature trees and the surrounding understory. Treatment methods proposed include foliar spraying during the height of the growing season for shrubs less than 5 feet and/or with steams less than 1 inch. Large plants will be semi-girdled using a chopping method that will result in loose flakes of bark and cambium material which will help to hold herbicide. A concentrated herbicide mix will be applied to those cuts. Mr. Outman stated comments have been received from Natural Heritage Endangered Species Program, which states the activity is exempt from review pursuant to 321 CMR 10.14. Those comments shall be provided for the record.

Carle Sciple made a motion to close the hearing and issue a Negative #2 Determination of Applicability for the area depicted as 6 on the plan titled Invasive Plant Inventory, Harvard Conservation Trust, Muller parcel – 31 ac., Harvard, Massachusetts, May 30, 2017. Jaye Waldron seconded the motion. The vote was unanimously in favor of the motion.

Jesse Johnson, of Bohler Engineering, was present to represent the applicant. Mr. Johnson explained the proposed project is for the removal of existing pavement that encroaches on to the abutting property in the Town of Harvard. The applicant is proposing the construction of a new fueling station at 28 Harvard Road, Ayer, which will be before the Ayer Conservation Commission soon. Upon removal of the existing pavement the area will be re-stabilized with loam and seed. Although all of the work to re-develop the site is outside the Harvard Conservation Commission jurisdiction, members discussed the proposed development of the site with Mr. Johnson.

Wendy Sisson made a motion to close the hearing and issue a Negative #3 Determination of Applicability with the conditions that the erosion controls to be inspected by the Conservation Agent prior to activity and once the disturbed area is stabilized it shall be inspected by the Conservation Agent to ensure there has been no introduction of invasive plant species. Carl Sciple seconded the motion. The vote was unanimously in favor of the motion.
