• Director's report.

- The outreach team has collaborated with our police, fire, and EMS on how we can best serve the frailer elders here in town. Going forward, the COA will be holding regular meetings with our emergency services and do our best to keep anyone from falling through the cracks. This will be done always keeping confidentiality in mind during these meetings.
- Our Farewell to Hildreth House party went very smoothly.
- COA also offered a "Spa Day" which was booked from beginning to end with manicures, massages, and mini facials. In fact, it was so popular, we will be having the Westford "A Spa for You" back again next month.
- Debbie answered the following questions from the Finance Committee on the COA's budget request: We asked for 150 increased hours to be added into the budget for FY24 to cover the increase in demand for the COA van. The Finance Committee wanted to see any documentation that shows we need those extra hours, so Lisa developed an excel form to show the increase this year compared to last fiscal year. For example, our van had a total of 698 requests for the entire year of FY22, and just in the last 6 months of FY23, we have already had 613 which shows an increase in rides. In addition to that, MART had a total of 884 rides in FY22, and so far, this year the COA has had 497 rides.
