Application for Community Preservation Funding

Please follow these guidelines as applicable:

- 1. Each project request must be submitted to the Harvard Community Preservation Committee using the FY2016 Funding Request form.
- 2. Appropriate support information to describe and document the need for the project must be included with the application.
- 3. Include a work schedule with description and estimated completion date of tasks and sub-tasks, showing final completion within three years of the appropriation.
- 4. Include quotes for project costs whenever possible. Cost estimates may be used, provided the basis of the estimate is fully explained.
- 5. If requested funds are part of a larger project or if the project is part of a longer-term project, describe the total project and total cost.
- 6. Project Tracking Forms for all of the applicant's open CPC funded projects must be up to date. Forms are due on June 1 and December 1 of each year from when the funds are available until the project is closed.
- 7. Include a copy of approved Encumbrance Form(s) for any previously appropriated, unspent CPC funds for which the project has passed the sunset date.
- 8. If applicant is submitting more than one application, the applicant must prioritize the projects.
- 9. A statement from the endorsing organization shall be submitted prior to the applicant making a presentation to the CPC. It should provide the endorser's recommendations to the CPC concerning the project including how the project fits within the long term goals of the sponsor.

In reviewing requests for funding, the Harvard Community Preservation Committee will consider evaluation criteria such as:

- 1. The leveraging capability of the grant. Can it be used to attract other funds?
- 2. The precedent setting capability of the grant. Will it serve as a 'model' for other projects?
- 3. The ability of the applicant to execute the grant. Is the project feasible and does the applicant have the skills and other resources to implement it?
- 4. Does the application fit within the restrictions of the Community Preservation Act? Can the CP dollars "make a difference"? Will its funds have a significant impact? Are there other, more appropriate sources of funding?
- 5. Consistency with the Town Master Plan goals and objectives.
- 6. Consistency with the Community Preservation Committee's Goals and Needs Assessments Reports.
