Morin motion to accept minutes of 10/24, Steele 2^{nd} , approved 3-0

Rec. Director status - TA met with council, 2 options brought up

- 2. Go to special TM in late January to redo warrant with new wording

P&R Property Studies

- P&R still must approve any money spent from SB on P&R land for any study done.

Steele motioned to allow SB to pay for wetland delineation studies on P&R properties @ or near Harvard Park, Morin 2^{nd} , approved 3-0

Beach

- Painting in staff area of beach house by Sam Levine
- Dock mooring project complete, docks are in winter position on pond, moorings to be completed in winter through the ice.
- Additional invoice received for new dock couplers.

Steele motioned to pay \$1355 for EZ Dock bill from revolving account, Morin 2nd, approved 3 – 0.

• November 13th all boats to be removed from beach and racks

Budget FY24

- O'Shea would like to zero out beach director position
- Would like to raise budget for beach expenses by 2.5%

Fields

- No core aeration due to not being able to flag sprinkler heads, DPW refused to help, postponed till spring.
- Steele getting signatures from 3 Seasons for work done on fields.
- 3 Seasons to use seed from DPW for upper depot seeding.
- Irrigation people to repair one valve box and was also able to get 4 benches by using grant money from state

Softball

- Much work done on the fields
- Steele met with ConsCom for approval to use fire pond water to help with watering new seeded patch. They wanted too many detailed questions. Result will be no watering of Ann Lees.
- Steele met with Liz Allard about guidance of mowing around Ryan Land.
- Steele brought up option to buy land in Devens for sports complex.
- O'Shea to reach out to HSC for payment of field use.

Field MOU

Steele making progress, also getting more details about structures on fields.

FY24 Budget

- Some money kept for porta-potty and scheduling software
- Money should be available in budget for use by new director for general expenses.

- Levine met with ADA groups; no report given
- Ski program after school is up and running and people are signing up.
- Katie Myer agreed to help Maureen Babcock with ski program.
- Ski starts Wednesday nights for six weeks beginning January 4th.
- Busses are already secured for ski program.
