PROGRAM UPDATES

BEACH

- O'Shea working on shifting some beach office costs to rec. director budget.
- Also adding cost to budget to cover mulch
- O'Shea moving new Bluetooth locks inside for the winter
- All boats tied down; sheds have been locked.
- Still have a few canoes on the racks
- O'Shea sent reminders to remove the canoes or face a \$50 impound fee.

FIELDS

Lower depot Project:

- Steels waiting for 3 Seasons to complete dormant seeding. Also waiting to see if irrigation will be repaired now or wait till spring.
- Steele to check on ordering benches
- O'Shea mentioned the town Amazon account to order equipment and supplies.

Steele to evaluate current bills before ordering benches.

Softball Field Modification:

- Benway overseeing the work to be done to the fields.
- Youth baseball is offering \$3500 towards new shed.

Field MOU:

- Steele working on field MOIU chart as to who owns what equipment and who is responsible for maintenance.
- Steele looking for input to complete chart.
- Steele is working on digging out the temporary fencing on Lower Depot that is buried in the weeds so
 DPW can mow
- Steele talked to Devens about the possibility of renting fields next season.
- Dave Boivert arranged a meeting w/ consultant from landscape engineering company that works on athletic fields. Proposal came in around \$13K
- P&R trying to figure out who will fund the proposal. CPIC money may be used. School may also need to chip in.
- ConsCom wants specific #'s of water usage @ Ann Lee's.
- O'Shea talked about field budget and added some \$ to cover handicap porta potty and fields scheduling software.

• Levine met with SEPAC about playground, and they are waiting to hear back from the consultants.
