#### o Draft Budget

Bob reviewed budget plan for next year, he and Michelle support budget with clubs added, clubs are added to attract more people to the beach

Reviewed 5% cut, maybe less sand, Doug mentioned 5% cut in beach director salary, therefore may need to take 10% out of beach expenses to keep beach directory budget the same, Michelle suggested running bonfire through donations

Last column includes paying for lifeguards from town budget

BHRA budget (40:00)

Michelle discussed meeting early in the day, price will go up in increment \$4,720, \$4,940, \$5,220, will get signatures from Linda and Pond Committee after Commission approval

Michelle motioned "to accept agreement between BHRA Inc. and Harvard Parks and Rec Commission, and allow my signature to represent P&R", Keith seconded vote **4-0** (Doug obtained)

o Kiosk, Lottery & Dock Closure Plans (46:45) Kiosk closed; boats need to be removed by 11/15 Swim rope and corner buoy still in water, Michelle will get removed

Fields (51:30) o Draft Budget Bob discussed budget and 5% reduction option - pass through to user fees; (Doug) we should fix hardware (like sprinkler heads); (Keith) cut costs of liming and fertilizing non-playing fields; deep aeration needed on Park and Waite

### o Ann Lees Field Jurisdiction/Responsibility Status (1:02:20)

Bob spoke with Wendy Sisson – MOU – inter-board memorandum - best approach, then NOI for operations and maintenance; going to ConCom on Thursday, therefore not approving now Generic NOI for all recreation fields, reviewed

o North Turf Infield Plan (1:23:40)

North Turf booked for the fall, can put us on schedule for the spring, will keep ACTION open

<u>Track and Commons (1:34:00)</u> o Bench Removal and apron repair status Will relook at Apron repair in the spring Bench removal – can Tim K. do this?
