HARVARD PLANNING BOARD MEETING MINUTES MARCH 20, 2017 APPROVED: APRIL 10, 2017

Vice Chair Erin McBee called the meeting to order at 7:05pm in the Town Hall Meeting Room, 13 Ayer Road, under M.G.L. Chapter 40A and the Code of the Town of Harvard Chapter 125

Members Present: Erin McBee, Michelle Catalina, Fran Nickerson and Rich Maiore (associate member)

Others Present: Liz Allard (LUB Admin.) and Bill Scanlan (Town Planner)

Board Members Reports

Catalina reported the request for proposals for 166 Littleton Road, the Poor Farm, are due Monday morning. The Municipal Affordable Housing Trust will be meeting that afternoon to review the proposals.

The Housing @ Hildreth House (H@HHC) Committee has reviewed the preliminary site plan and has provided comments back to the engineer. The site plan details the width of the road at 24'; Scanlan wondered if 20' would be suitable to match the width of the existing driveway. The H@HHC requested the revised plan:

- Reduce the number of units within the buildings;
- Reduce the number total units;
- Provide exclusive open space, as required by 125-55E(2);
- Reduce to one car garage, and
- Include crawlspaces as opposed to buildings on a concrete slab.

The Planning Board requested there be:

- Direct access to the Hildreth House for units adjacent to the Hildreth House, as required by 125— 5G(6);
- Provide screening from the abutters,
- Roadway to remain at 24' as proposed; and
- Fire access to be addressed by the Fire Chief.

Planner Report

Scanlan provided updated results from the commuter rail shuttle survey that had been previously provided to the Board. Scanlan stated he has spoken with Montachusett Regional Planning Commission who has stated Harvard is not eligible for a second MART van for this service. Nickerson stated the

Council on Aging (COA) would want a second van in order to make this service work in conjunction with existing services provided by COA. The survey will close at the end of next week.

Scanlan stated there is a grant opportunity for consultation and technical assistance for the development of an open space design bylaw, known as Conservation Assistance for Small Communities. After a brief discuss members requested Scanlan confirm whether funding under this grant would be available for a financial analysis of this type of development.

District Local Technical Assistance Grants

Scanlan stated the Board had agreed to revisit this grant opportunity, which has an application deadline of April 3rd. After a brief discussion members agreed to pursue assistance on a water resource protection bylaw under this grant.
